

**无锡职业技术学院国际学生购买综合保险管理规定**  
**Regulations on Purchasing Comprehensive Insurance by**  
**International Students of Wuxi Institute of Technology**

According to the *Management Measures of Schools in Enrolling and Cultivating International Students* (Ministry of Education No. 42) and *Interim Regulations on Requirements for International Students to Purchase Insurance in Colleges and Universities* (Jiao wai si lai (2007) No. 1078), in order to improve the emergency response mechanism for international students and safeguard their legitimate rights and interests, the Regulations are hereby formulated:

**Article 1** The college imposes compulsory comprehensive insurance for international students. All international students registered at our college shall purchase comprehensive insurance for foreign students studying in China (hereinafter referred to as *the Insurance*) on China's mainland. International students shall provide proof of insurance when registering for admission and applying for visa certificates.

**Article 2** According to the actual situation of international students in Jiangsu Province, our college has selected China Ping An Life Insurance Co., Ltd. (hereinafter referred to as "Ping An Insurance") as the insurer of comprehensive insurance for international students. The cost of insurance for self-funded students shall be borne by themselves.

**Article 3** International students studying and living in our college shall purchase insurance in accordance with relevant national regulations and college requirements. According to the length of study in the college, long-term students purchase insurance based on academic year, and short-term students purchase insurance based on semester or month. The college will issue a residence permit for the same period as that of the insurance. International students who plan to study temporarily for one semester, but may continue to study or transfer in the second semester, shall purchase an additional month of insurance (7 months in total).

**Article 4** International students shall purchase insurance in accordance with relevant national regulations and college requirements. Those who fail to purchase insurance in accordance with regulations shall get insured within the specified time limit. International students who fail to purchase insurance within the time limit will not be admitted by the college; for international students who have already studied at the college, yet have

not been insured shall be withdrawn from college or declined from registration.

**Article 5** After purchasing insurance, international students who suspend their studies, drop out or transfer to other institutions outside Jiangsu province can apply for a refund from Ping An Insurance with the certificate of change of student status issued by the college.

**Article 6** The college will sign a comprehensive insurance liability agreement for international students studying in China with Ping An Insurance as group. International students who have purchased insurance must pay tuition fees and register on time, and the college will assist in claiming settlement if accidents occur during the academic years. International students who have purchased insurance yet have not paid the registration fee on time shall claim settlement by themselves with Ping An Insurance.

**Article 7** For the premium rate, validity period and detailed insurance responsibilities, please refer to the "Ping An Insurance Comprehensive Insurance Plan for International Students".

**Article 8** The Regulations enters into effect as of the date of issuance.

**Article 9** The School of International Education is responsible for the interpretation of the Regulations.
