国际学生评奖评优实施细则（修订）

**Wuxi Institute of Technology**  
**Rules for the Implementation of Award Evaluation and Merit**  
**Appraisal for International Students (Revised)**

In order to implement the fundamental task of better cultivating students by strengthening moral integrity, further promote the construction of international students' academic conduct, encourage students to achieve better performance, and give full play to the exemplary role of advanced models, these rules are formulated.

**Article 1 Scholarship for HSK**

(I) Assessment criteria

1. Strictly comply with Chinese laws and regulations, school rules; have good behaviors and habits; strictly implement the Code of Conduct for International Students; actively participate in collective activities and perform outstandingly in various activities organized by the college.
2. Pass the HSK Level 3, HSK Level 4, or HSK Level 5 test at one time.

(II) Evaluation ratio and amount of reward

The amount of scholarship for HSK is 500 yuan/(person/time), and international students who pass HSK Level 3, HSK Level 4, or HSK Level 5 test at one time can participate in the evaluation, and the ratio is not limited.

**Article 2 Scholarship for Academic Excellence**

(I) Assessment criteria

1. Strictly comply with Chinese laws and regulations, school rules; have good behaviors and habits; strictly implement the Code of Conduct for International Students.
2. Study seriously and diligently with clear purpose and proper attitude; strictly abide by all study disciplines; finish homework seriously; achieve excellent grades; take no make-up exams; rank in the top 30% of the class.

3. Pass the HSK Level 4 test and achieve a score of 85 or above in the course *General Introduction to China*.

#### (II) Evaluation ratio and amount of reward

The scholarship amount and evaluation ratio for the first class scholarship are 1000 Yuan/(person/semester) and 3% of the number of students, and 600 Yuan/(person-semester) and 5% of the number of students for the second class scholarship.

### **Article 3 Outstanding Graduates**

#### (I) Evaluation Criteria

1. Strictly comply with Chinese laws and regulations, school rules; have good behaviors and habits; strictly implement the Code of Conduct for International Students.
2. Be awarded the scholarship for academic excellence twice or more during the school period.
3. Be ranked within the top ten of the class in the overall ranking during the school period and take no make-up exams.
4. Pass the HSK Level 4 test and score 85 or above in the course *General Introduction to China*.
5. Actively participate in various cultural, sports and volunteer activities.
6. No punishment of discipline violation during the school years.
7. Preference will be given to those who have outstanding performance in further studies and business start-ups under the same conditions.

#### (II) Evaluation ratio and amount of reward

Evaluation ratio: The evaluation is carried out on a class basis. In principle, the evaluation ratio shall not exceed 5% of the number of students in the class. The evaluation criteria for first and second prize winners of international competitions or national competitions organized by the educational administrative department can be appropriately relaxed and they do not account for the class quota.

Amount of reward: 200 yuan/person

### **Article 4 Others**

1. The evaluation of awards and appraisals of merits should be realistic and highlight quality, and the results must be made public after the initial evaluation and before the final evaluation of various awards for supervision.

2. International students who have any objection to the result could reflect to the School of International Education, which shall deal with the matter within 3 working days after acceptance. International students who still have objections can file an appeal within 3 working days after being handled by the School of International Education.

3. If the approved award-winning students are found to have falsified or seriously violated the discipline and regulations of the college during the evaluation period, their awards shall be canceled, the certificates and prizes shall be revoked, and disciplinary actions shall be taken.

**Article 5** The implementation rules shall be implemented from the date of publication, and if there are any provisions inconsistent with these rules, these rules shall prevail.
